On January 9, 2020, at approximately 1214 hours, the Modesto Area CHP received a call of a traffic collision on State Route 33, just north of W. Stanislaus Road. Emergency personnel arrived on scene and located a tractor trailer combination and a Hyundai sedan blocking both direction of State Route 33. Unfortunately, the driver of the Hyundai, a 20 year old female adult, was pronounced deceased at the collision scene. No other injuries were sustained. Our preliminary investigation reveals Party 2 was driving a 2018 Volvo tractor trailer combination (semi) northbound State Route 33, north of W. Stanislaus Road. Party 1, was driving a 2013 Hyundai directly behind the Volvo. Party 1 entered the southbound traffic lane to pass the Volvo. At this time, Party 3 was driving a 2016 Freightliner tractor trailer combination (semi) southbound State Route 33, directly towards the Hyundai. The Freightliner and Hyundai collided head-on. Both the Freightliner and Hyundai came to rest on State Route 33, blocking both directions of travel. Caltrans was summoned to the collision scene and provided a detour for motorists. Drugs and/or alcohol do not appear to have contributed to this collision.
